Health and Nutrition: Buyer agrees to keep puppy in good health and physical condition and maintain regular vaccinations and proper deworming, flea and tick prevention, and heartworm prevention. Puppy must also be given proper shelter, fresh food and water, and adequate exercise. Genetics only play about 35% role in dog's overall health. We strongly advise you to only use **Pawtree** for the first year without lapse in order to start the puppy out on the right track for overall health and growth. We have them on **Pawtree Whitefish and Brown Rice.**

Guarantees: Seller is in compliance with all Florida State and Charlotte County laws to make every effort to ensure that the puppy is healthy in the time of transfer. No puppy will be allowed to leave our home before 8 weeks of age, passed

their health inspection by our licensed veterinarian, free from illnesses, and eating quite well on their own. Your new puppy **must** be taken to your vet within 72 hours to validate this guarantee.

Banfield is NOT an approved vet by T.A.G. and will void this guarantee. If your vet finds puppy unfit for sale upon the exam, it will be replaced provided puppy is returned with a written statement from the vet stating the nature of their findings. **T.A.G has the right to have puppy examined by their vet prior to any exchange.** SELLER IS NOT RESPONSIBLE FOR MEDICAL EXPENSES THAT BUYER HAS INCURRED.

The seller is not responsible shall you choose to administer the LEPTOSPIROSIS vaccine. We do not give this to our dogs due to adverse reactions and side effects. If buyer chooses to give this vaccine, costs or long term illnesses associated with it will be the responsibility of the buyer. Please do your research and make an informed decision **BEFORE** the first vet appointment. **I have added information in your puppy packet, so please read carefully.**

Your puppy has received their first vaccines and will need boosters upon your vets schedule. Over vaccination can cause harm to your puppy, so please look at the health certificate because the vaccination dates are there. Then the boosters can be scheduled accordingly. It is the responsibility of the buyer to set up an immunization schedule with a veterinarian. Seller assumes no responsibility for any illnesses to other household pets due to being exposed to your new puppy.

Seller cannot guarantee the puppy against opportunistic parasites brought on by the stress of moving from our home to yours. Stress can ignite illnesses and parasites such as. But not limited to, hypoglycemia, coccidia, giardia, kennel cough, etc. Seller can not guarantee the puppy to be worm free as this is an ongoing process that is out of sellers control once the buyer has taken possession of the puppy. These are problems that are easily treated and are the

responsibility of the buyer. SELLER SHALL NOT BE RESPONSIBLE FOR MEDICAL EXPENSES INCURRED BY THE BUYER.

This guarantee does cover expenses associated with spaying or neutering, nor does it cover injury or death from routine surgical procedures. Furthermore, it does not cover any of the following conditions or minor flaws: coccidia, giardia, hypoglycemia, kennel cough, ear mites, pneumonia, ear infections, skin mites, mange, allergies, cherry eye, or other non-threatening eye, skin, or tissue issues, over or under bites, hernias, Non-threatening bone or joint disorders such as but not limited to luxating patellas and heart murmurs that are not life threatening.

I GIVE NO REFUND AND WILL NOT BE RESPONSIBLE IF YOUR PUPPY EATS A POISONOUS PLANT, FOOD, MEDICINE, OBJECT, OR POISON OR GETS HIT BY CAR OR RUNS AWAY.

PLEASE REMEMBER DOGS ARE CURIOUS AND IT IS BUYERS RESPONSIBILITY TO KEEP THEM SAFE!

PLEASE DO NOT EXPOSE YOUR PUPPY TO UNVACCINATED DOGS UNTIL THEY HAVE COMPLETED THEIR VACCINES AROUND 16-20 WEEKS.

T.A.G IS NOT RESPONSIBLE FOR CONTRACTIBLE DISEASES IF BUYER DOES NOT ADHERE TO THIS RECOMMENDATION.

THE GUARANTEE DOES NOT COVER MINOR COLDS, ALLERGIES, PARASITES, HERNIAS. HOWEVER, BREEDER WILL DISCLOSE ANY KNOWN ISSUE PRIOR TO SELL.

ABUSE/NEGLECT in the event that the dog is mistreated, neglected, abused in any way, kept outside in extreme heat/cold conditions kept on wire flooring, seller has the right to rescue the dog immediately with no notice or compensation to Buyer. Buyer shall voluntarily surrender any kennel club registrations papers (if applicable), microchip records, health records.

I do not cover any surgery related umbilical hernias, if your puppy should have one or any problems associated with one. Your puppy has been offered at a discount if there is one present as we disclose any faults at time of sale. ***I do not guarantee size as puppies can inherit genes from either parent.*** The buyer must agree to provide veterinary care within this first year, including annual heartworm checks and preventatives and to keep vaccinations current. Failure to comply with and provide documentation of the above requirements voids this warranty. Hypoglycemic shock and death is covered within 72 hours after leaving my premises. If your puppy were to die as a result of hypoglycemic issues within 72 hours, I will refund the purchase price of the puppy. Vet bills treating this condition are not covered. At this time of transfer, you assume all continued health care of the puppy and accept all responsibilities of pet ownership and accept the puppy as is on the date of sale.

If the buyer complies with all of the terms contained within this agreement, then the seller warrants the health of the puppy for one (1) Year of life against genetic life threatening defects.

The dog must NOT be bred unless breeding rights were purchased prior. **BREEDING YOUR PUPPY WITHOUT BREEDING RIGHTS RENDERS THIS CONTRACT NULL AND VOID ENTIRELY.**

IF FOR ANY REASON BUYER CAN NO LONGER CARE FOR PUPPY, PUPPY MUST NEVER BE SURRENDERED TO A SHELTER. SELLER WILL REHOME
